I would have gotten someone else

I took exactly what you gave me as a list when we talked over the phone. I thought you were a man of integrity.

# Shane:

I am I thought u new when a guy <u>says a two bedroom townhouse</u> with 2 couxhes a love seat two queen beds a childs bed and dresser and boxes that u wpuld know it wouldnt fit in a cube van u need a three ton atleast not something to move a one bedroom apartment. the boxes alone would take up most of your truck and the bigger furniture would take the other so u need way bigger of a truck I could have paid someone the same price or less for the same job and only one trip now I need to hire someone else to finish your job

# Bradley:

Your wife told me she had seen my truck around many times. She also told me the only things that mattered were the items that she pointed to which was the same as the list you gave me. You did not say any thing about boxes and neither did she . I did as I was hired to do. I will lower only to my original quote of 1645 + gst = 1727.25

You need to man up and business man up to you commitments.

### Shane:

ishe saw your truck and she said take certain things after she saw that it wouldnt fit everything She said she saw my truck around town a number if times.

### Bradley:

Those are my notes un yge pic i sent as we talked. You said 2 beds 2 dressers 2 couchs and a live seat. You said only the big stuff

### Shane:

nope no chance im paying double for a job u couldn't complete sorry ill send u some money for your costs but im not getting nailed on this one . you should have said the size of your truck and I would habe said it wouldnt have fit everything poor communication on your part

### Bradley:

I do these trips all the time. And my clients are always very happy with my service and prices

Shane:

<u>I said u dis a good job and was happy with everything</u> except the move wasnt completed <u>I agreed on</u> <u>1600</u> for the place to be moved now if u go there and u need to do more then one trip thats your problem not mine sorry

u said something about the mattressbing on the sides and boxes to fill the spaces up top. bottom line I made a deal to move <u>my townhouse for 1600</u> u did not move my place u moved about 1/3 to a 1/2 job not complete. I thought I was being ok with giving u something for your half job or so

Bradley:

You are not being ok.

And I know the industry really well. And you appear to have no idea.

Here a couple ov pics to show how I take notes notice the # of boxes mentioned.

I moved some one from Edmonton lately to storage the cost was in excess of 4G

I am moving them out if storage with truck and trailer 15 min down the road. That part will be \$1000. That is normal.

So . . What is your bottom line.

Take into consideration what I moved for you . . If it was across town it would have been 550 + gst. With your deal as you stated it I brought my man. Normally I would have hired a guy at each end. At less cost.

Shane:

dont care about other only care about my stuff my price and I fired u to move my place and its not done so thats it period

Bradley: So what's it ? So what is your proposal ?

Shane:

I couldn't care less what u wrote I told u most of the major items I told u no appliances and said there is the usual stuff and boxes . if u never wrote everything down not my problem . because of your <u>negligence it has costed me time from work had to close today drive to nelson and back and hire</u> another mover for 1500

Bradley: So what are you offering me ?

Shane:

im not happy and this has costed me over double because of u . I already called my lawyer and its your negligence

Bradley: Wow man I am TOTALY FLABERGASTED . . that you could be like this.

Bradley:

So you are offering to pay nothing . . Is that correct ?

Bradley:

Hey I thought you were closed today. So you could drive to nelson and what not. But as you answered your biz phone and you have a fire suppression guy in . . I guess that makes you a lier about everything else.
